The following is a transcript of a video made available to employees of CVS Health Corporation on December 7, 2017:

CVS Health and Aetna: Addressing the Unmet Need

Larry Merlo and Mark Bertolini

Larry Merlo: Mark we've been, we've been partners since, you know, 2010.

Mark Bertolini: Yes.

Larry Merlo: I could remember some of the earlier conversations that we had.

Mark Bertolini: Mm-hmm (affirmative).

Larry Merlo: And by the way, we've solved a lot of problems together.

Mark Bertolini: We have.

Larry Merlo: There were issues that we had in the business, and, and we worked together to solve them for the betterment of the clients and customers that we serve, and I remember you and I having dinner in a restaurant talking about, Okay, now that we've got the blocking and tackling down...

Mark Bertolini: Mm-hmm (affirmative).

Larry Merlo: ...how do we start thinking about a more strategic partnership, what can we do? And, I remember calling you when we eliminated tobacco, Mark we finally made the decision, we're not a convenience store, we're a pharmacy that has a convenience offering. We're becoming more of a healthcare company. And I know you followed that.

Mark Bertolini: Right.

Larry Merlo: And I was following the actions that you were taking in terms of moving from being more than a payer, in terms of getting closer to the customer

Mark Bertolini: Mm-hmm (affirmative).

- Larry Merlo:** So when you sit here and think about the challenges that we have in healthcare, the unmet need how do we start to bend the cost curve while helping people achieve their best health?
- Mark Bertolini:** Mm-hmm (affirmative).
- Larry Merlo:** You know, I can't think of a better partner to come together to create a new journey.
- Mark Bertolini:** I think it was a forgone conclusion. I mean, you were focused on health and we were moving more toward healthcare and away from just being a financier of healthcare, and that model coming together in this place where the best of what you do coming together with the best of ours is going to be very powerful, because these consumers are now going to be able to come to a place near their home, or get help at their home as a result of all the offerings you have, and we in the background can provide a better level of coordination, benefits, copays, and make this all very seamless for the customer. The single biggest line item budget in their home budget, worst experience possible on the planet.
- Larry Merlo:** Yes.
- Mark Bertolini:** Nobody likes the healthcare system.
- Larry Merlo:** And, and we all know people, it could be neighbors, friends, and if somebody gets sick, where do they come to? Because they know we're in healthcare, they come to us, in terms of how can you help me? How can you help me navigate all the complexity that I'm now faced with?
- Mark Bertolini:** Mm-hmm (affirmative).
- Larry Merlo:** And we can begin to close that gap.
