Good Morning Everyone,

We all learned of some very exciting news this morning. You have likely seen the company-wide communications from Steve, but if you haven't, I encourage you to review the materials and video he sent at your earliest convenience. I want to clarify a few items that may be a little more specific to our Sales and Marketing Operations.

The first thing to emphasize is that while we have announced an exciting transaction, the acquisition of ILG will not be completed until later this year. Until then, things should remain business as usual. We will continue to operate as two separate companies, and our job is to keep our focus on the performance of Marriott Vacations Worldwide.

Representations about our product do not change as a result of this announcement. No one should speculate about the impact this transaction could have on our products or any future benefits it may bring. Our industry is highly regulated, and unauthorized representations can result in both extended rescission rights for the purchaser and potential legal liability for the Company.

Per policy, no one should speak with the media or opine on social media about this pending transaction. The short answer to inquiries is that we are incredibly excited about our future, but beyond the talking points that have already been provided to the sales force, there is no further information to share at this time. You can also emphasize that we are committed to doing what is best for the customers of both companies for the long term and will keep customers informed as appropriate.

You should now be armed with everything you need to handle questions and properly represent this situation, both internally and externally. If you receive questions for which you don't have answers, it's OK to acknowledge that many

decisions have not yet been made. Importantly, please do not speculate! We will be working hard to bring this transaction to a close before year-end and will share additional information as things develop and it is appropriate to do so.

We are very excited about the future at MVW!
