<b>Use of Proceeds:</b>	We intend to use the net proceeds to repay existing indebtedness, including under our senior unsecured revolving credit facility entered into in June 2013, as amended (the 2013 Credit Facility ), and under our senior unsecured revolving credit facility entered into in January 2012 and amended and restated in September 2014, as further amended (the 2014 Credit Facility ).
<b>Capitalization:</b>	The as further adjusted column in the Capitalization section of the Preliminary Prospectus Supplement gives effect to the receipt of approximately \$1,231.0 million after deducting discounts and commissions payable to the underwriters and estimated expenses payable by us, and the use of approximately \$526.0 million of the net proceeds to repay existing outstanding indebtedness under the 2013 Credit Facility and \$705.0 million of the net proceeds to repay existing outstanding indebtedness under the 2014 Credit Facility.
