- (1) The registrant previously registered securities with an aggregate offering price not to exceed \$150,000,000 on a Registration Statement on Form F-3, (File No. 333-221806), which was filed by the registrant on November 29, 2017 and as amended by Amendment No. 1 to Registration Statement on Form F-3 on December 22, 2017 and by Amendment No. 2 to Registration Statement on Form F-3 on January 11, 2018, and declared effective by the Securities and Exchange Commission (the Commission) on January 12, 2018 (the Prior Registration Statement). There currently remains \$52,500,000 in unsold securities under the Prior Registration Statement. In accordance with Rule 462(b) under the Securities Act of 1933, as amended, an additional amount of securities having a proposed maximum aggregate offering price of \$10,500,000 is hereby registered, representing no more than 20% of the maximum aggregate offering price of unsold securities under the Prior Registration Statement. In no event will the maximum aggregate offering price of all securities issued pursuant to this Registration Statement and the Prior Registration Statement exceed the amount registered under such Registration Statements.

This registration statement is being filed with respect to the registration of additional securities of Teekay Corporation pursuant to Rule 462(b) promulgated under the Securities Act of 1933, as amended. The earlier registration statement on Form F-3, as amended (File No. 333-221806) (the Prior Registration Statement) was declared effective by the Securities and Exchange Commission on January 12, 2018. The information set forth in the Prior Registration Statement and all exhibits to the Prior Registration Statement are incorporated by reference in this registration statement. This registration statement is being filed solely to increase the amount of securities offered pursuant to the Prior Registration Statement.
