- (1) The 9,197 shares disposed of reflect 7,302 shares withheld by the issuer to fund the cashless exercise of 12,500 options on 12/07/12, and 1,895 shares withheld by the issuer to cover the associated tax liability.
- (2) Cashless exercise of options on December 7, 2012
- (3) The 8,957 shares disposed of reflect 6,925 shares withheld by the issuer to fund the cashless exercise of 12,500 options on 12/07/12, and 2,032 shares withheld by the issuer to cover the associated tax liability.
- (4) The 8,949 shares disposed of reflect 6,912 shares withheld by the issuer to fund the cashless exercise of 12,500 options on 12/07/12, and 2,037 shares withheld by the issuer to cover the associated tax liability.

Upon vesting, we will pay the RSUs in shares of our Common Stock from those shares reserved for issuance under the 2008 Equity Plan. Value to be established upon vesting.

- (7) Each Restricted Stock Unit (RSU) represents a contingent right to receive one share of ProAssurance Corporation common stock, issuable from the ProAssurance 2008 Equity Incentive Plan. The RSUs will vest if the reporting person remains continuously employed by ProAssurance or one of its subsidiaries until December 31, 2014 (three years from date of grant).
