TENDER OFFER

This Tender Offer Statement on Schedule TO relates to the offer (the "Offer") by CMG LEGACY INCOME FUND, LLC, CMG INCOME FUND II, LLC, CMG LEGACY GROWTH FUND, LLC, CMG ACQUISITION CO., LLC AND CMG PARTNERS, LLC (collectively the "Purchasers") to purchase up to 300,000 shares of each Class B-2 and B-3 common stock (the "Shares") in Healthcare Trust of America, Inc. (the "REIT"), the subject company, at a purchase price equal to \$7.00 and \$6.50 per Share, respectively, upon the terms and subject to the conditions set forth in the Offer to Purchase dated February 8, 2013 (the "Offer to Purchase") and the related Agreement of Assignment and Transfer.

The Offer resulted in the tender by shareholders, and acceptance for payment by the Purchasers, of a total of approximately 23,301 each of Class B-2 Shares and 24,301 Class B-3 Shares.

Following purchase of all of the tendered Shares, the Purchaser will own an aggregate of approximately 323,301 B-2 Shares and 324,304 Class B-3 Shares, or approximately 0.6% of the total outstanding Shares of each class.
