(3) The phantom stock units were accrued under the Harris Corporation 2005 Directors' Deferred Compensation Plan and are to be settled in cash upon the reporting person's retirement and other events.

(4) On March 30, 2005, Harris Corporation distributed a stock dividend, payable to all holders of record of common stock on March 14, 2005, of 1 share of common stock for each share of common stock outstanding. The aggregate of 14,102.77 phantom stock units includes phantom units acquired on 3/30/05 as a result of the 2-for-1 split and 11.35 units acquired through dividend reinvestment in the Harris Corporation 2005 Directors' Deferred Compensation Plan on 3/10/05.
