- (1) On March 14, 2007, the closing price of Issuer's common stock on the NYSE was \$6.31. No consideration was paid by the Reporting Person in connection with this common stock.

Grant of restricted stock units on March 14, 2006 that vest in equal one-third increments on March 14, 2007, 2008 and 2009.
