(the "Issuer") owned by multiple private investment funds for which Mr. Semler serves as the principal and controls the investment decisions (the "Funds"). Pursuant to Rule 16a-1, Mr. Semler disclaims such beneficial ownership.  
 The Funds hold the Common Stock for their own accounts. Mr. Semler serves as the manager to the Funds' general partners. As such, Mr. Semler receives an allocation of a portion of net profits from and owns a partnership interest in the Funds. Mr. Semler reports the Common Stock held by the Funds because, as the manager of the Funds' general partners at the time of purchase, Mr. Semler controlled the disposition and voting of the Common Stock.
