- (1) These shares of common stock will vest three years from the date of grant.
- (2) Certain of these shares of common stock are subject to vesting based on certain time and performance requirements.

(3) The option for the purchase of 14,000 shares, which option was granted to Mr. Adelman, vested on the first, second and third anniversary of the grant date of November 9, 2005 in the proportion of 34%, 33% and 33%, respectively. The remaining option to purchase 3,000 shares will vest on December 31, 2009, provided that certain performance targets established by the Company's board or compensation committee are attained.

- (4) These stock options vest in five equal annual installments commencing on January 3, 2007.
