The reporting person holds previously reported options to buy 71,275 Common Shares (with tandem tax withholding rights) under the Invacare Corporation 2003 Performance Plan, granted in reliance upon the exemption provided by Rule 16b-3. All options were granted between November 16, 1999 and December 11, 2008, at an exercise price between \$10.695 and \$47.01 per share, will expire between November 16, 2009 and August 20, 2018 and became or will become exercisable between December 31, 2000 and January 1, 2012. The current balance reflects the expiration of 1,000 options on March 2, 2009.
