(1) The option is exercisable in five equal annual installments beginning on January 10, 2009.

Options were granted by Marine Bancorp. Upon merger with Home BancShares on 6/1/05, these options became 100% vested. However, prior to the merger, 696 options were vested with an expiration date of 12/31/2009 and 271 options were vested with an expiration date of 3/31/2011. The remaining 56 options were vested on 6/1/05 with an expiration of 3/31/2011. Upon conversion, 2,089 options have an expiration of 12/31/2009 and 982 options have an expiration of 3/31/2011.
