The shares vest in one-quarter increments on 3/1/2010, 3/1/2011, 3/1/2012 and 3/1/2013.

(3) The shares are owned by the Joseph Marion Molina, M.D. Separate Property Trust, of which Dr. Molina is sole trustee.

(4) The shares are owned by JMM GRAT 1208/2, of which Dr. Molina is beneficiary.

(5) The shares are owned by JMM GRAT 1208/5, of which Dr. Molina is beneficiary.

(6) The shares are owned by the Molina Family, LLC, of which Dr. Molina is the sole manager.

(7) The shares are owned by the Joseph Marion Molina, M.D., Remainder Trust I, of which Dr. Molina is trustee and beneficiary.

The shares are owned by the Molina Family Partnership, L.P., of which Dr. Molina is the sole general partner. Dr. Molina and his spouse each hold a 0.5% ownership interest in the partnership. The remaining 99% of ownership interests in the partnership are held in equal (8) amounts by the Joseph Marion Molina, M.D. Annuity Trust No. 1, the Joseph Marion Molina, M.D. Annuity Trust No. 2 and the Joseph Marion Molina, M.D. Annuity Trust No. 3. Dr. Molina is trustee and certain immediate family members of Dr. Molina are the beneficiaries of these trusts.
