Pursuant to the Endo Pharmaceuticals Directors Stock Election Plan, on November 29, 2010, Mr. Montague elected to receive 25% of his 2011 cash retainer fees and 25% of his 2011 meeting fees in Endo common stock. At the time that the retainer and meeting fees would otherwise have been payable, the number of shares of Endo common stock are fixed and are reported as of such date on Table I as an acquisition of securities. These cash retainer and meeting fees are payable to Mr. Montague in consideration of his services on the Endo Pharmaceuticals Holdings Inc. Board of Directors, Audit Committee, Nominating & Governance Committee and Pricing Committee for the second quarter 2011 meetings and the second quarter 2011 retainer fee. Under the Endo Pharmaceuticals Directors Deferred Compensation Plan, also on November 29, 2010, Mr. Montague elected to defer receipt of all of these shares.

(1) This number represents (i) 5,677 restricted stock units and (ii) 9,347 shares of common stock, receipt of which has been deferred under the Endo Pharmaceuticals Directors Deferred Compensation Plan. Mr. Montague's beneficial ownership disclosed in this table excludes all shares held by Mr. Montague indirectly, including shares underlying stock options.
