The number of securities beneficially owned represents the number of PSUs indirectly credited to the reporting person account through a unitized fund investment option under PNC's Supplemental Incentive Savings Plan ("SISP"), and reflects 49 PSUs indirectly acquired for the account of the reporting person through dividend equivalents under the SISP provided subsequent to the reporting person's most recent Form 4 filing that included information pertaining to the SISP. Approximately 98% of the unitized fund assets consist of PSUs, and the remainder consists of notional investments in a money market fund. The percentages of assets in the unitized

fund investment option that are deemed to be invested in PNC common stock may vary from time to time.
