Due to the Dividend Record date of 01/02/2014, the foregoing RSUs received dividend equivalents on the Dividend Payment Date of 01/15/2014. Therefore, a total of 284 RSUs were automatically paid out in the form of shares of Common Stock on 01/15/2014.
