- As previously reported, on September 28, 2012, the reporting person received a grant of 37,500 restricted units that vest ratably on each of the first, second and third anniversaries of the date of grant. The second anniversary occurred on September 26, 2014, resulting in the
- (1) vesting and settlement of 12,500 shares of common stock, as shown in Table I. The remaining 12,500 restricted units are shown in Table II, which are scheduled to vest on September 28, 2015. Restricted units are settled in shares of the Company's common stock upon vesting.
 - (2) All historical share data in this Form 4 have been restated to reflect a one-for-four reverse stock split, effective as of October 11, 2012.
 - (3) Shares withheld for payment of taxes upon vesting of restricted units in accordance with Rule 16b-3.
