- (1) Each Restricted Stock Unit, which is the economic equivalent of one share of Visteon common stock, automatically vested on March 27, 2016 and was converted and paid to me in common stock without any election or action on my part. The value of each share was based on the fair market value of Visteon common stock as of March 24, 2016, the next preceding trading day.
- (2) The shares were withheld by Visteon to satisfy income tax withholding obligations arising in connection with the vesting of certain Restricted Stock Units. The value of each share was based on the fair market value of Visteon common stock as of March 24, 2016, the next preceding trading day.
- (3) These shares are owned by a parent of the reporting person and subject to a power of attorney that allows the reporting person to dispose of such shares.
