The 2015 Annual Meeting of Stockholders (the “2015 Annual Meeting”) of TSR, Inc. (the “Company”) was held on December 9, 2015. The following matters were submitted to the stockholders of the Company at the 2015 Annual Meeting for their approval:

Election of Directors

The stockholders of the Company elected each of Joseph F. Hughes and Raymond A. Roel to serve as a Class I Director of the Company for a three-year term. The balloting for the election was as follows:
