- (1) For options granted in any one year, one-seventh of the options of such grant vest and become exercisable on the grant date of the anniversary each year commencing on the first anniversary after the grant.
- (2) Options expire 3 years after vesting.
- (3) The reporting person elected to defer receipt of 34,690 shares of common stock issuable upon the exercise of stock options. 28,026 of the deferred shares were used to pay the exercise price and taxes on the options. The reporting person elected to diversify the 6,664 shares of
