(1) Represents restricted stock units granted to Steven S. Sintros under the UniFirst Corporation Amended and Restated 2010 Stock Option and Incentive Plan. Such restricted stock units vest 20% per year on each anniversary of the grant date with the first vesting occurring on the first anniversary of the grant date.

(2) Includes 279 shares of unrestricted common stock. Also includes 1,008 restricted stock units that will vest in two equal annual installments on October 22, 2019 and October 22, 2020.
