However, none of the trustees, acting alone, can vote or exercise dispositive authority over Shares
- (1) held by the Mildred Trust. Accordingly, Alaska Trust, Ms. Ciciora and Mr. Sippy disclaim beneficial ownership of the Shares beneficially owned, directly or indirectly, by the Mildred Trust.
