- (1) These common shares were acquired upon the vesting and settlement of certain restricted stock units.

- (4) Each restricted stock unit represents a contingent right to receive one share of TFS Financial Corporation common stock. Restricted stock units are entitled to dividend equivalent rights in the form of a cash payment in the amount of any cash dividend paid per share of common stock.
- (5) As reported on a Form 4 dated January 2, 2013, the reporting person received a grant of 5,800 Restricted Stock Units ("RSUs") on December 28, 2012. These RSU's vest in three equal annual installments beginning December 15, 2013.
- (6) The reporting person received a grant of 49,200 stock options on December 17, 2015. These stock options vest in three equal annual installments beginning December 10, 2016.
- (7) The reporting person received a grant of 4,500 Restricted Stock Units ("RSUs") on December 17, 2015. These RSUs vest in three equal annual installments beginning December 10, 2016.
- (8) As reported on a Form 4 dated May 18, 2010, the reporting person received a grant of 3,600 restricted stock units ("RSUs") that vest in four equal annual installments beginning May 14, 2011.
