Mr. Snyder transferred 135,602 shares of FactSet Common Stock from The Charles J. Snyder 2010 Grantor Retained Annuity Trust to The Charles J. Snyder 2008 Family Trust, of which Susan J. Snyder is the sole trustee. He will maintain indirect beneficial ownership of the shares held by Family trust.

- (4) Mr. Snyder transferred 505,000 shares of FactSet Common Stock to The Charles J. Snyder 2012 Grantor Retained Annuity Trust, of which Mr. Snyder is the sole trustee. He will have complete authority in connection with the shares held by the trust.

Note that 1,467,110 of Mr. Snyder's shares are held directly and that an additional 1,000,000 shares are held indirectly as follows:

- (5) 258,600 shares held in The Charles J. Snyder 2008 Family Trust, 236,400 shares in the 2011 Grantor Retained Annuity Trust and the remaining 505,000 shares in 2012 Grantor Retained Annuity Trust.
