 This amount includes 7,768.766 shares acquired by Mr. DeNaples individually through the DRP; and 22.814 shares acquired jointly with his spouse through the DRP. Therefore, Mr. DeNaples holds 1,751,508.221 shares individually and 5,128.502 shares jointly with his spouse.
- (2) Mr. DeNaples spouse is a participant in FNCB Bancorp, Inc.'s Dividend Reinvestment and Stock Purchase Plan ("DRP"). These transactions are the result of her participation in the DRP during June 2018.
