(1) No shares were sold - these shares were withheld by the Issuer to satisfy tax withholding requirements in connection with the vesting of restricted stock units.

(2) Each restricted stock unit represents a contingent right to receive one share of the Issuer's common stock.

(3) The reporting person received restricted stock units, 1/16th of which vests on 6/15/19, and an additional 1/16th of which vests each quarter thereafter. Upon vesting, the reporting person will receive a number of shares of common stock equal to the number of restricted stock units that have vested.
