- Consists of 39,905 shares of common stock and shares issuable under a restricted stock award ("RSA") and restricted stock units ("RSUs"). The RSA includes 33,334 shares of restricted stock granted to the reporting person. 16,667 shares will vest on May 1, 2018, and the remaining shares will vest on May 1, 2019. Upon vesting, the reporting person will receive a number of shares of common stock equal to the number of restricted stock shares that have vested. The RSU's consist of (1) an award of 13,333 RSUs where 6,666 will vest on June 16, 2018, and the remainder will vest on June 16, 2019; (2) an award of 53,334 RSUs where 26,667 will vest on June 16, 2018 and the remainder will vest on June 16, 2019; and (3) an award of 20,000 RSU's that vest in 20% annual increments on each of the first five anniversaries of March 6, 2018. Each RSU represents the right to receive one share of common stock upon vesting.
- (1) The option became exercisable in 20% annual increments on each of the first five anniversaries of April 18, 2013.
- (2) The option became exercisable in 33.33% annual increments on each of the first three anniversaries of May 25, 2016.
