- (1) Mr. Bigelow did not stand for re-election to the Board at the Annual Meeting on April 23, 2018. 17,493 previously granted Deferred Stock Units converted to shares of Crane Co. Common Stock on that date.
- (2) Each Deferred Stock Unit represents the right to receive one share of Crane Co. common stock upon separation from service on the Board of Directors.
- (3) Additional Deferred Stock Units are granted during the year to coincide with payment of dividends on Crane Co. Stock.
- (4) Following separation from service on the Board of Directors, the Director will receive one share of Crane Co. common stock for each Deferred Stock Unit; however, if the Director's service terminates before the first anniversary of the Grant, except for reasons of death, or a change in control of Crane Co., then the right to receive such shares will expire.
