- The Form 4 filed on November 27, 2017 inadvertently reported the sale of 13,503 shares as trustee of the Winifred M. Kelley Trust. As executor of his mother's estate, Mr. Kelley was not the beneficial owner of the shares and the estate's transactions effected by Mr. Kelley (1) in his capacity as executor of the estate during the 12 months after his appointment, are not reportable under Section 16, pursuant to Rule 16a-2(d)(1). This amended Form 4 is being filed to remove this transaction. As of November 27, 2017, Mr. Kelley held 264,003 shares of common stock directly and Mr. Kelly's spouse held 2,250 shares of common stock.
