As previously reported, on 7/16/03, the Issuer granted 100,000 shares of restricted stock to the Reporting Person. On 7/21/04, the Reporting Person voluntarily forfeited, for no consideration, 76,667 of those shares. The Reporting Person has retained 23,333 of those (1) shares, 8,333 of which will vest on 7/16/06 and 15,000 of which will vest on 7/16/08, subject to the Reporting Person's compliance with certain non-compete, non-solicitation and confidentiality obligations. Also includes 1,600 shares subject to forfeiture restrictions that lapse on 7/17/06.
