- (1) The phantom stock units are accrued under the PHC DSU Plan. The units are settled 100% in the Company's common stock upon the reporting person's retirement or upon approved hardship reasons. The conversion or exercise price is one phantom stock unit for one share of the Company's common stock.
- (2) Equal installments of 33 1/3 of the option shares granted will become exercisable on the completion of one, two, and three years of service measured from the grant date, respectively. The options will expire ten years from the grant date. 5,250 option shares granted 1-2-02 have strike price of \$23.47 per share, 5,250 option shares granted 1-2-03 have a strike price of \$28.15 per share, 5,250 options granted 1-1-04 have a strike price of \$33.35 per share, and 5,250 option shares granted 1-1-05 have a strike price of \$34.15.
