This Amendment No. 2 to Schedule 13G (this "Amendment No. 2") is filed with respect to the common stock, par value \$0.01 per share (the "Common Stock") of Cadiz Inc., a corporation organized under the laws of the State of Delaware (the "Company"), to amend the Schedule 13G filed on February 12, 2010 (as amended by this Amendment No. 2, the "Schedule 13G"), in accordance with the annual amendment requirements. Capitalized terms used but not defined herein have the meaning ascribed thereto in the Schedule 13G.

Item 4: Ownership:

Item 4 of the Schedule 13G is hereby amended and restated as follows:

The beneficial ownership of Common Stock by the Reporting Persons, as of the date of this Amendment No. 2 and as of the date of the event that triggered the filing of this Amendment No. 2, is as follows:

A. Altima Partners

(a) Amount beneficially owned: 967,259. This amount consists of (i) 919,259 shares of Common Stock and (ii) 48,000 shares of Common Stock which would be received upon exercise of 48,000 warrants convertible into Common Stock (the "Warrants").

(b) Percent of class: 7.0%. The percentages used herein and in the rest of this Amendment No. 2 are calculated based upon a total of 13,725,772 shares of Common Stock outstanding, which consists of (i) 13,677,772 shares of Common Stock issued and outstanding as of November 8, 2010, as reflected in the Company's Form 10-Q for the quarterly period ended September 30, 2010 and (ii) 48,000 shares of Common Stock issuable upon exercise of the Warrants.
