Explanation of Responses:

- (1) On December 29, 2015, the reporting person exercised 7,500 stock options, delivered 6,104 shares of Common Stock of the Company for cancellation in payment of the exercise price of such options, and had 515 shares of Common Stock of the Company withheld and cancelled to cover minimum required tax withholding. These shares cancellations are shown in Table I as dispositions (Transaction Code "D" in column 4), although none of these cancelled shares were sold in the market, as indicated by Transaction Code "F" in column 3.
- (2) The NFG stock fund under the NFG 401(k) plan is denominated in units, representing ownership interests in a fund that includes both NFG common stock and a reserve of cash. The information reported represents the dollar value of the reporting person's balance in the
