DTE Energy Company (“DTE Energy”) will host DTE Energy Analyst Day in New York, New York on May 1, 2013. DTE Energy management will provide a business update to the DTE Energy Analyst Day at approximately 8:30 a.m. EST May 1, 2013. A copy of the slide presentation from the business update is furnished as Exhibit 99.1. The business update presentation will be available via live webcast and archived for future viewing through a link on DTE Energy's website, www.dteenergy.com. In the business update presentation, In these meetings and in the slide presentation discussed below, In the meetings and the presentation, DTE Energy increases its 2013 operating earnings per share guidance to \$3.90-\$4.20 per share and provides an early outlook for its 2014 operating earnings per share guidance of \$4.12-\$4.42 per share.

In the slide presentation and this filing, DTE Energy discusses 2013 and 2014 operating earnings guidance. It is likely that certain items that impact the company's 2013 and 2014 reported results will be excluded from operating results. Reconciliations to the comparable 2013 and 2014 reported earnings guidance are not provided because it is not possible to provide a reliable forecast of specific line items. These items may fluctuate significantly from period to period and may have a significant impact on reported earnings.
