On June 3, 2015, PartnerRe Ltd. (“**PartnerRe**”) issued a press release in response to the lawsuit filed by EXOR S.p.A. (“**EXOR**”) in the Supreme Court of Bermuda regarding its request for PartnerRe to disclose certain information related to PartnerRe’s shareholder base.

On June 2, 2015, EXOR sent a letter to PartnerRe extending the expiration date of its offer to July 26, 2015. The letter did not modify the terms of EXOR’s proposed merger agreement.
