The average price of prescriptions has increased more than 200% over the last eight years. Together, our solutions will help offset the rising cost of drugs.

A combination with CVS Health will allow us to continue to build on our momentum with a partner that shares our commitment to promoting wellness, health, and convenient access to high-quality health care for everyone.
