Market-Linked Notes Based on the EURO STOXX 50[®] Index Due December 3, 2019

Overview

The notes offered by this pricing supplement are unsecured senior debt securities issued by Citigroup Global Markets Holdings Inc. and guaranteed by Citigroup Inc. Unlike conventional debt securities, the notes do not pay interest. Instead, the notes offer the potential for a positive return at maturity based on the performance of the EURO STOXX 50[®] Index (the “underlying index”) from the initial index level to the final index level.

The notes provide 1-to-1 exposure to the absolute value of the performance of the underlying index within a limited range of potential appreciation or depreciation. If the underlying index appreciates from the initial index level to the final index level by up to 11%, you will receive a positive return at maturity equal to that appreciation. In addition, if the underlying index depreciates by up to 11%, the notes provide for a positive return at maturity based on the absolute value of that depreciation. **However, if the underlying index appreciates or depreciates by more than 11%, you will receive a fixed return of 1.50% at maturity regardless of the extent of that appreciation or depreciation.** As the notes do not pay any interest, even if the underlying index appreciates or depreciates so that you receive a positive return at maturity, there is no assurance that your total return at maturity on the notes will compensate you for the effects of inflation or be as great as the yield you could have achieved on a conventional debt security of ours of comparable maturity.

In exchange for these features, investors in the notes must be willing to forgo (i) participation in any appreciation of the underlying index of more than 11%, (ii) positive participation in the absolute value of any depreciation of the underlying index of more than 11%, and (iii) any dividends that may be paid on the stocks that constitute the underlying index during the 1.5-year term of the notes. **If the underlying index appreciates or depreciates by less than 1.50% from the pricing date to the valuation date, you will receive a return on the notes that is less than the fixed return, and if the underlying index does not appreciate or depreciate at all, you will not receive any positive return on your investment in the notes.**

In order to obtain the modified exposure to the underlying index that the notes provide, investors must be willing to accept (i) an investment that may have limited or no liquidity and (ii) the risk of not receiving any amount due under the notes if we and Citigroup Inc. default on our obligations. **All payments on the notes are subject to the credit risk of Citigroup Global Markets Holdings Inc. and Citigroup Inc.**

Hypothetical Examples

The diagram below illustrates your payment at maturity for a range of hypothetical percentage changes from the initial index level to the final index level.

Investors in the notes will not receive any dividends that may be paid on the stocks that constitute the underlying index. The diagram and examples below do not show any effect of lost dividend yield over the term of the notes. (2) Hypothetical total return on notes at maturity = (a) (i) the value of the payment at maturity *minus* (ii) the \$1,000 stated principal amount per note, *divided by* (b) \$1,000 stated principal amount per note.

The examples below are intended to illustrate how your payment at maturity will depend on whether the final index level is greater than, equal to or less than the initial index level and by how much.

Example 1—Upside Scenario A. The hypothetical final index level is 3,599.55 (a 5.00% increase from the initial index level), which is **greater than** the initial index level but **less than** the upside knock-out level.

Payment at maturity per note = \$1,000 + the note return amount

= \$1,000 + the upside return amount

= \$1,000 + (\$1,000 × the index percent change)

= \$1,000 + (\$1,000 × 5.00%)

= \$1,000 + \$50.00

= \$1,050.00

Because the underlying index appreciated from the initial index level to the hypothetical final index level and the hypothetical final index level was less than the upside knock-out level, you would receive a note return amount of \$50.00 per note, reflecting 1-to-1 exposure to the appreciation of the underlying index, and your total return on the notes at maturity would be 5%.

Example 2—Upside Scenario B. The hypothetical final index level is 5,142.21 (a 50.00% increase from the initial index level), which is **greater than** the upside knock-out level.

Payment at maturity per note = \$1,000 + the note return amount

= \$1,000 + the fixed return amount

$$= \$1,000 + \$15.00$$

Because the underlying index appreciated from the initial index level to the hypothetical final index level and the hypothetical final index level was greater than the upside knock-out level, you would receive a note return amount of \$15.00 per note, equal to the fixed return amount, and your total return on the notes at maturity would be 1.50%. In this scenario, an investment in the notes would underperform a hypothetical alternative investment providing 1-to-1 exposure to the appreciation of the underlying index without an upside knock-out level acting as a cap on the return.

Example 3—Upside Scenario C. The hypothetical final index level is 3,256.73 (a 5.00% decrease from the initial index level), which is **less than** the initial index level but **greater than** the downside knock-out level.

Payment at maturity per note = \$1,000 + the note return amount

$$= \$1,000 + \text{the downside return amount}$$

$$= \$1,000 + (\$1,000 \times \text{the absolute value of the index percent change})$$

$$= \$1,000 + (\$1,000 \times |-5.00\%|)$$

$$= \$1,000 + \$50.00$$

$$= \$1,050.00$$

Because the underlying index depreciated from the initial index level to the hypothetical final index level and the hypothetical final index level was greater than the downside knock-out level, you would receive a note return amount of \$50.00 per note, reflecting 1-to-1 exposure to the absolute value of the depreciation of the underlying index, and your total return on the notes at maturity would be 5%.

Example 4—Upside Scenario D. The hypothetical final index level is 1,028.44 (a 70.00% decrease from the initial index level), which is **less than** the downside knock-out level.

Payment at maturity per note = \$1,000 + the note return amount

= \$1,000 + the fixed return amount

= \$1,000 + \$15.00

= \$1,015.00

Because the underlying index depreciated from the initial index level to the hypothetical final index level and the hypothetical final index level was less than the downside knock-out level, you would receive a note return amount of \$15.00 per note, equal to the fixed return amount, and your total return on the notes at maturity would be 1.50%.

Example 5—Par Scenario. The hypothetical final index level is 3,428.14 (a 0.00% change from the initial index level), which is **equal to** the initial index level.

Payment at maturity per note = \$1,000 + the note return amount

= \$1,000 + the upside return amount

= \$1,000 + (\$1,000 × the index percent change)

= \$1,000 + (\$1,000 × 0.00%)

= \$1,000 + \$0.00

= \$1,000.00

Because the underlying index remained the same from the initial index level to the hypothetical final index level, the note return amount would be \$0.00 per note and you would receive a payment at maturity equal to the \$1,000 stated principal amount per note. In this scenario, your total return on the notes at maturity of 0% would be less than the fixed return.

If the underlying index appreciates or depreciates by less than 1.50% from the pricing date to the valuation date, you will receive a return on the notes that is less than the fixed return and if the underlying index does not appreciate or depreciate at all, you will not receive any positive return on your investment in the notes.

Summary Risk Factors

An investment in the notes is significantly riskier than an investment in conventional debt securities. The notes are subject to all of the risks associated with an investment in our conventional debt securities (guaranteed by Citigroup Inc.), including the risk that we and Citigroup Inc. may default on our obligations under the notes, and are also subject to risks associated with the underlying index. Accordingly, the notes are suitable only for investors who are capable of understanding the complexities and risks of the notes. You should consult your own financial, tax and legal advisors as to the risks of an investment in the notes and the suitability of the notes in light of your particular circumstances.

The following is a summary of certain key risk factors for investors in the notes. You should read this summary together with the more detailed description of risks relating to an investment in the notes contained in the section “Risk Factors Relating to the Notes” beginning on page EA-6 in the accompanying product supplement. You should also carefully read the risk factors included in the accompanying prospectus supplement and in the documents incorporated by reference in the accompanying prospectus, including Citigroup Inc.’s most recent Annual Report on Form 10-K and any subsequent Quarterly Reports on Form 10-Q, which describe risks relating to the business of Citigroup Inc. more generally.

Your potential return on the notes is limited and may significantly underperform the underlying index. If the underlying index appreciates, you will participate in such appreciation on a 1-to-1 basis only if the final index level is less than or equal to the upside knock-out level. Because the upside knock-out level is equal to 111% of the initial index level, the total return on the notes in this scenario cannot exceed 11%. If the underlying index depreciates, you will receive the absolute value of such depreciation on a 1-to-1 basis only if the final index level is greater than or equal to the downside knock out level. Because the downside knock-out level is equal to 89% of the initial index level, the total return on the notes in this scenario cannot exceed 11%. If the underlying index appreciates such that the final index level is greater than the upside knock-out level or the underlying index depreciates such that the final index level is less than the downside knock-out level, you will not positively participate in such appreciation or depreciation and instead will receive a fixed return of 1.50%. Thus, in no circumstance will the total return on the notes exceed 11%, and an investment in the notes may significantly underperform the underlying index.

You may receive less than the fixed return and potentially no return on your investment in the notes. If the underlying index appreciates or depreciates by less than 1.50% from the pricing date to the valuation date, you will receive a return on the notes that is less than the fixed return, and if the underlying index does not appreciate or depreciate at all, you will not receive any positive return on your investment in the notes. As the notes do not pay any interest, even if the underlying index appreciates or depreciates from the initial index level to the final index level so that you receive a positive return, there is no assurance that your total return at maturity on the notes will be as great as could have been achieved on conventional debt securities of ours of comparable maturity.

The notes do not pay interest. Unlike conventional debt securities, the notes do not pay interest or any other amounts prior to maturity. You should not invest in the notes if you seek current income during the term of the notes.

Although the notes provide for the repayment of the stated principal amount at maturity, you may nevertheless suffer a loss on your investment in real value terms if the underlying index does not appreciate or depreciate sufficiently from the initial index level to the final index level or you receive the fixed return. This is because inflation may cause the real value of the stated principal amount to be less at maturity than it is at the time you invest, and because an investment in the notes represents a forgone opportunity to invest in an alternative asset that does generate a positive real return. You should carefully consider whether an investment that may not provide for any return on your investment, or may provide a return that is lower than the return on alternative investments, is appropriate for you.

Investing in the notes is not equivalent to investing in the underlying index or the stocks that constitute the underlying index. You will not have voting rights, rights to receive dividends or other distributions or any other rights with respect to the stocks that constitute the underlying index. As of May 29, 2018, the average dividend yield of the underlying index was approximately 3.53% per year. While it is impossible to know the future dividend yield of the underlying index, if this average dividend yield were to remain constant for the term of the notes, you would be forgoing an aggregate yield of approximately 5.30% (assuming no reinvestment of dividends) by investing in the notes instead of investing directly in the stocks that constitute the underlying index or in another investment linked to the underlying index that provides for a pass-through of dividends. The payment scenarios described in this pricing supplement do not show any effect of lost dividend yield over the term of the notes. If the underlying index appreciates, or if it depreciates by up to the dividend yield, this lost dividend yield will likely cause the notes to underperform an alternative investment providing for a pass-through of all dividends and 1-to-1 exposure to the performance of the underlying index.

Your payment at maturity depends on the closing level of the underlying index on a single day. Because your payment at maturity depends on the closing level of the underlying index solely on the valuation date, you are subject to the risk that the closing level of the underlying index on that day may be lower, and possibly significantly lower, than on one or more other dates during the term of the notes. If you had invested in another instrument linked to the underlying index that you could sell for full

value at a time selected by you, or if the payment at maturity were based on an average of closing levels of the underlying index, you might have achieved better returns.

The notes are subject to the credit risk of Citigroup Global Markets Holdings Inc. and Citigroup Inc. If we default on our obligations under the notes and Citigroup Inc. defaults on its guarantee obligations, you may not receive anything owed to you under the notes.

The notes will not be listed on any securities exchange and you may not be able to sell them prior to maturity.

The notes will not be listed on any securities exchange. Therefore, there may be little or no secondary market for the notes. CGMI currently intends to make a secondary market in relation to the notes and to provide an indicative bid price for the notes on a daily basis. Any indicative bid price for the notes provided by CGMI will be determined in CGMI's sole discretion, taking into account prevailing market conditions and other relevant factors, and will not be a representation by CGMI that the notes can be sold at that price, or at all. CGMI may suspend or terminate making a market and providing indicative bid prices without notice, at any time and for any reason. If CGMI suspends or terminates making a market, there may be no secondary market at all for the notes because it is likely that CGMI will be the only broker-dealer that is willing to buy your notes prior to maturity. Accordingly, an investor must be prepared to hold the notes until maturity.

Sale of the notes prior to maturity may result in a loss of principal. You will be entitled to receive at least the full stated principal amount of your notes, subject to the credit risk of Citigroup Global Markets Holdings Inc. and Citigroup Inc., only if you hold the notes to maturity. The value of the notes may fluctuate during the term of the notes, and if you are able to sell your notes prior to maturity, you may receive less than the full stated principal amount of your notes.

The estimated value of the notes on the pricing date, based on CGMI's proprietary pricing models and our internal funding rate, is less than the issue price. The difference is attributable to certain costs associated with selling, structuring and hedging the notes that are included in the issue price. These costs include (i) the selling concessions paid in connection with the offering of the notes, (ii) hedging and other costs incurred by us and our affiliates in connection with the offering of the notes and (iii) the expected profit (which may be more or less than actual profit) to CGMI or other of our affiliates in connection with hedging our obligations under the notes. These costs adversely affect the economic terms of the notes because, if they were lower, the economic terms of the notes would be more favorable to you. The economic terms of the notes are also likely to be adversely affected by the use of our internal funding rate, rather than our secondary market rate, to price the notes. See "The estimated value of the notes would be lower if it were calculated based on our secondary market rate" below.

The estimated value of the notes was determined for us by our affiliate using proprietary pricing models. CGMI derived the estimated value disclosed on the cover page of this pricing supplement from its proprietary pricing models. In doing so, it may have made discretionary judgments about the inputs to its models, such as the volatility of the underlying index, dividend yields on the stocks that constitute the underlying index and interest rates. CGMI's views on these inputs may differ from your or others' views, and

as an underwriter in this offering, CGMI's interests may conflict with yours. Both the models and the inputs to the models may prove to be wrong and therefore not an accurate reflection of the value of the notes. Moreover, the estimated value of the notes set forth on the cover page of this pricing supplement may differ from the value that we or our affiliates may determine for the notes for other purposes, including for accounting purposes. You should not invest in the notes because of the estimated value of the notes. Instead, you should be willing to hold the notes to maturity irrespective of the initial estimated value.

The estimated value of the notes would be lower if it were calculated based on our secondary market rate. The estimated value of the notes included in this pricing supplement is calculated based on our internal funding rate, which is the rate at which we are willing to borrow funds through the issuance of the notes. Our internal funding rate is generally lower than our secondary market rate, which is the rate that CGMI will use in determining the value of the notes for purposes of any purchases of the notes from you in the secondary market. If the estimated value included in this pricing supplement were based on our secondary market rate, rather than our internal funding rate, it would likely be lower. We determine our internal funding rate based on factors such as the costs associated with the notes, which are generally higher than the costs associated with conventional debt securities, and our liquidity needs and preferences. Our internal funding rate is not an interest rate that we will pay to investors in the notes, which do not bear interest.

Because there is not an active market for traded instruments referencing our outstanding debt obligations, CGMI determines our secondary market rate based on the market price of traded instruments referencing the debt obligations of Citigroup Inc., our parent company and the guarantor of all payments due on the notes, but subject to adjustments that CGMI makes in its sole discretion. As a result, our secondary market rate is not a market-determined measure of our creditworthiness, but rather reflects the market's perception of our parent company's creditworthiness as adjusted for discretionary factors such as CGMI's preferences with respect to purchasing the notes prior to maturity.

The estimated value of the notes is not an indication of the price, if any, at which CGMI or any other person may be willing to buy the notes from you in the secondary market. Any such secondary market price will fluctuate over the term of the notes based on the market and other factors described in the next risk factor. Moreover, unlike the estimated value included in this pricing supplement, any value of the notes determined for purposes of a secondary market transaction will be based on our secondary market rate, which will likely result in a lower value for the notes than if our internal funding rate were used. In addition, any secondary market price for the notes will be reduced by a bid-ask spread, which may vary depending on the aggregate stated principal amount of the notes to be purchased in the secondary market transaction, and the expected cost of unwinding related hedging transactions. As a result, it is likely that any secondary market price for the notes will be less than the issue price.

The value of the notes prior to maturity will fluctuate based on many unpredictable factors. The value of your notes prior to maturity will fluctuate based on the level and volatility of the underlying index and a number of other factors, including the price and volatility of the stocks that constitute the underlying index, the dividend yields on the stocks that constitute the underlying index, interest rates generally, the volatility of the exchange rate between the U.S. dollar and the euro, the correlation between that exchange rate and the level of the underlying index, the time remaining to maturity and our and Citigroup Inc.'s creditworthiness, as reflected in our secondary market rate. Changes in the level of the underlying index may not result in a comparable change in the value of your notes. You should understand that the value of your notes at any time prior to maturity may be significantly less than the issue price.

Immediately following issuance, any secondary market bid price provided by CGMI, and the value that will be indicated on any brokerage account statements prepared by CGMI or its affiliates, will reflect a temporary upward adjustment. The amount of this temporary upward adjustment will steadily decline to zero over the temporary adjustment period. See "Valuation of the Notes" in this pricing supplement.

The EURO STOXX 50® Index is subject to risks associated with non-U.S. markets. United States Federal Tax Considerations

In the opinion of our counsel, Davis Polk & Wardwell LLP, based on current market conditions, the notes should be treated as “contingent payment debt instruments” for U.S. federal income tax purposes, as described in the section of the accompanying product supplement called “United States Federal Tax Considerations—Tax Consequences to U.S. Holders—Notes Treated as Contingent Payment Debt Instruments,” and the remaining discussion is based on this treatment. The discussion herein does not address the consequences to taxpayers subject to special tax accounting rules under Section 451(b) of the Internal Revenue Code of 1986, as amended (the “Code”).

If you are a U.S. Holder, you will be required to recognize interest income during the term of the notes at the “comparable yield,” which generally is the yield at which we could issue a fixed-rate debt instrument with terms similar to those of the notes, including the level of subordination, term, timing of payments and general market conditions, but excluding any adjustments for the riskiness of the contingencies or the liquidity of the notes. We are required to construct a “projected payment schedule” in respect of the notes representing a payment the amount and timing of which would produce a yield to maturity on the notes equal to the comparable yield. CGMI calculated the estimated value of the notes set forth on the cover page of this pricing supplement based on proprietary pricing models. CGMI’s proprietary pricing models generated an estimated value for the notes by estimating the value of a hypothetical package of financial instruments that would replicate the payout on the notes, which consists of a fixed-income bond (the “bond component”) and one or more derivative instruments underlying the economic terms of the notes (the “derivative component”). CGMI calculated the estimated value of the bond component using a discount rate based on our internal funding rate. CGMI calculated the estimated value of the derivative component based on a proprietary derivative-pricing model, which generated a theoretical price for the instruments that constitute the derivative component based on various inputs, including the factors described under “Summary Risk Factors—The value of the notes prior to maturity will fluctuate based on many unpredictable factors” in this pricing supplement, but not including our or Citigroup Inc.’s creditworthiness. These inputs may be market-observable or may be based on assumptions made by CGMI in its discretionary judgment.

The estimated value of the notes is a function of the terms of the notes and the inputs to CGMI’s proprietary pricing models.
