Commerce Bancshares, Inc. (Commerce) and West Pointe Bancorp, Inc. (West Pointe) completed the acquisition of West Pointe through a merger of the two entities. The transaction, valued at \$80.9 million in stock and cash, became effective on September 1, 2006. Commerce s acquisition of West Pointe adds approximately \$460 million in assets, \$259 million in gross loans and \$392 million in total deposits.
