On May 29, 2007, the Compensation Committee of our board of directors agreed to increase the annual salary of F. Barry Bays, our Executive Chairman of the Board, to \$250,000. The increase in Mr. Bays' salary was based upon his assuming the interim responsibilities of Vice President, Product Development. Mr. Bays assumed these interim responsibilities on February 26, 2007, upon a change in the duties of Jeffrey G. Roberts, our former Senior Vice President and Chief Technology Officer. Mr. Bays' annual salary will be \$250,000, in effect from February 26, 2007, until a permanent Vice President, Product Development is secured, at which time Mr. Bays' annual salary will return to \$100,000.
