Item 1. Security and Issuer.

This schedule related to the common stock of Precision Optics Corporation, Inc. (the ?Issuer?). The Issuer?s principal executive officers are located at 22 East Broadway, Gardner, MA 01440.

Item 2. Identity and Background.

The persons filing this report are Austin W. Marxe (?Marxe?) and David M. Greenhouse (?Greenhouse?), who are the controlling principals of AWM Investment Company, Inc. (?AWM?), the general partner of and investment adviser to Special Situations Cayman Fund, L.P. (?Cayman?). AWM also serves as the general partner of MGP Advisers Limited Partnership (?MGP?), the general partner of and investment adviser to Special Situations Fund III, L.P. (?SSF3?). Marxe and Greenhouse are also members of SST Advisers, L.L.C. (?SSTA?), the general partner of and investment adviser to Special Situations Technology Fund, L.P. (?Technology?) and the Special Situations Technology Fund II, L.P. (?Tech II?). (SSF3, Cayman, SSPE, Technology and Tech II will hereafter be referred to as, the ?Funds?).

The principal office and business address of the Reporting Persons, is 153 East 53rd Street, 55th Floor, New York NY 10022.

The principal business of each Fund is to invest in equity and equity-related securities and other securities of any kind or nature.

Mr. Marxe and Mr. Greenhouse have never been convicted in any criminal proceeding (excluding traffic violations or similar misdemeanors), nor have either of them been a party to any civil proceeding commenced before a judicial or administrative body of competent jurisdiction as a result of which he was or is now subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws. Mr. Marxe and Mr. Greenhouse are citizens of the United States.

### Item 3. Source and Amount of Funds or Other Consideration.

Each Fund utilized its own available net assets to purchase the securities referred to in this Schedule.

### Item 4. Purpose of Transaction.

The securities referred to in this Schedule have been acquired by each of the Funds for investment purposes and not with the purpose or effect of changing or influencing control of the Issuer. Each Fund acquired the securities in the ordinary course of business and is holding the securities for the benefit of its investors.

### Item 5. Interest in Securities of the Issuer.

Cayman owns .6% of the shares outstanding, SSF3 owns 20.4% of the shares outstanding, Technology owns 0% of the shares outstanding and Tech II owns 9.2% of the outstanding shares. Messrs. Marxe and Greenhouse share the power to vote and direct the disposition of 2,116,997 of Common Stock owned by each of the Funds. Messrs. Marxe and Greenhouse are deemed to beneficially own a total of 2,116,997 shares of Common Stock or 30.2% of the outstanding shares.

The purpose of the amended 13D is to report a typographical error made in the prior filing. As of July 21, 2004 the Special Situations Fund III, L.P. held 1,428,962 shares of common stock and the Special Situations Cayman Fund, L.P. held 40,115 shares of common stock. There were no other acquisitions or depositions that took place prior to July 21, 2004, other than those reported in the prior 13D.

### Item 6. Contracts, Arrangements, Understandings or Relationships With Respect to Securities of the Issuer.

No contracts, arrangements, understandings or similar relationships exist with respect to the securities of the Company between Messrs. Marxe and Greenhouse and any other individual or entity.
