(QP), Special Situations Technology Fund, L.P. (Tech) and Special Situations Technology II, L.P. (Tech II), respectively. 225,794 warrants are held by QP, 117,857 warrants are held by Tech and 805,952 warrants are held by Tech II. The interest of Marxe and Greenhouse in the shares of Warrants owned by SSQP, Tech and Tech II is limited to the extent of his pecuniary interest.
