The remaining RSUs will vest in five equal annual installments of which two are remaining on each of 7/29/2018 and 7/29/2019.

(5) RSUs do not have an expiration date.

(6) RSUs granted under the Fresh Del Monte Produce Inc. 2014 Omnibus Share Incentive Plan. Each RSU represents a contingent right to receive one ordinary share of FDP. The RSUs will vest in five equal annual installments of which one is remaining 7/30/2018.
