## MTS ANNOUNCES SUBSCRIBER GROWTH NUMBERS FOR OCTOBER 2006

MOSCOW, RUSSIAN FEDERATION NOVEMBER 13, 2006 MOBILE TELESYSTEMS OJSC ( MTS - NYSE: MBT), THE LARGEST MOBILE PHONE OPERATOR IN RUSSIA AND THE CIS, ANNOUNCES THAT ITS CONSOLIDATED SUBSCRIBER BASE REACHED 68.53 MILLION USERS ON OCTOBER 31, 2006.

During October 2006, MTS consolidated subscriber base increased by 0.94 million subscribers, of which 0.23 million were added in Russia.
