This Amendment No. 1 to Schedule TO amends and supplements the Offer to Amend Eligible Options (the "Offer") filed with the Securities and Exchange Commission on March 23, 2007, in connection with the offer by Synopsys, Inc. (the "Company") to certain option holders to amend certain portions of certain stock options in order to limit the potential adverse personal tax consequences that may apply to these stock options under Section 409A of the Internal Revenue Code of 1986, as amended, and the proposed regulations issued by the U.S. Internal Revenue Service thereunder. The Amendment is being filed in order to (1) extend the duration of the Offer in order to provide certain newly identified Eligible Optionees the required time period in which to make an election whether to amend their Eligible Options and (2) file as exhibits to the Schedule TO a presentation to be made to Eligible Optionees at employee meetings and certain other communications necessary as a result of the extension of the Offer.
