MOSCOW, RUSSIAN FEDERATION MAY 18, 2007 MOBILE TELESYSTEMS OJSC (MTS - NYSE: MBT), THE LARGEST MOBILE PHONE OPERATOR IN RUSSIA AND THE CIS, ANNOUNCES THAT ITS CONSOLIDATED SUBSCRIBER BASE REACHED 74.52 MILLION USERS ON APRIL 30, 2007.

During April 2007, MTS consolidated subscriber base increased by 0.36 million subscribers.
