DEREGISTRATION OF UNSOLD SECURITIES

On September 7, 2007, Synvista Therapeutics, Inc. (the "Company") filed a Registration Statement on Form S-3, as amended (File No. 333-145935) (the "Registration Statement"), to register 628,268 shares of the Company's common stock, par value \$0.01 per share (the "Common Stock").
