(2) Represents options to purchase the Issuer's Class A Common Stock, \$0.001 par value ("Common Stock").

An option to purchase 32,743 shares of the Issuer's Common Stock was issued to the Reporting Person under the Issuer's 2005 Omnibus Equity Plan. 8,185 shares of Common Stock become exercisable on October 19, 2011, and an additional 8,186 shares become exercisable on each of October 19, 2012, October 19, 2013 and October 19, 2014.
