- Effective December 6, 2001, Castle Harlan Affiliates III, L.P. distributed all of the 1,468,295 shares of Universal Compression Holdings, Inc. (UCO) Common Stock owned by it to its partners (the "Distribution"). Each of Castle Harlan Associates III, L.P., Castle Harlan
- (1) Affiliates III, L.P. and Castle Harlan Offshore Partners III, L.P. in turn distributed all shares of UCO's Common Stock received by it in the Distribution to its respective partners. As a result of the Distribution, the Reporting Person acquired 213 shares of Common Stock of UCO.
- (2) Includes 729 shares through the Employee Supplemental Savings Plan, 3,595 shares through the Employee Stock Purchase Plan (of which 289 of these are held directly) and 892 shares through the 401(k) Plan.
