Explanation of Responses:

- (1) On September 26, 2005, Mr. Wallace received a grant of restricted stock units ("RSUs") covering 25,000 shares of KLA-Tencor common stock. On September 26, 2010, Mr. Wallace vested in fifty percent (50%) of such RSUs.
Pursuant to the terms of the September 26, 2005 RSU grant, 5,835 shares of KLA-Tencor common stock were automatically withheld at vesting to cover required tax withholding. Because the vesting date of such RSUs occurred on a day on which the NASDAQ Stock Market was closed for trading, the fair market value of KLA-Tencor common stock used for purposes of calculating the number of shares to be withheld was the closing price of KLA-Tencor common stock as reported on the last completed trading day immediately prior to such vesting date.
 - (3) Each RSU represents a contingent right to receive one share of KLA-Tencor common stock.
