Item 1.01. Entry into a Material Definitive Agreement

On September 22, 2010, the Company subsidiary INTL Commodities, Inc., entered into an Amended and Restated Credit Agreement with BNP Paribas as Administrative Agent, Collateral Agent, an Issuing Bank and the Swing Line Lender, ABN AMRO Bank N.V. and Rabobank Nederland, New York Branch, as additional Issuing Banks, and with the lenders from time to time parties to the Credit Agreement, pursuant to which the amount available under this syndicated loan facility was increased from \$92 million to \$140 million. The loan proceeds will continue to be used to finance INTL Commodities activities and are secured by INTL Commodities assets.
